- Oct. 1** First day to file 2019-20 Free Application for Federal Student Aid (FAFSA). www.fafsa.gov

- March 1** Scholarship application deadline for KCC Foundation awards for 2019-20 award year.
- June 20** Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the Aug. 2, 2019 fall preregistration payment date.*
- Aug. 2** Fall preregistration payment due date.
- Sept. 6** Fall 2019 Financial Aid Eligibility date – be enrolled for all fall courses, including 8-week and late starting, by this date.
- Sept. 20** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting fall classes.

- Jan. 31** Spring 2020 Financial Aid Eligibility date - be enrolled for all spring courses, including 8-week and late starting, by this date.
- Feb. 14** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting spring classes.
- March 1** Scholarship application deadline for KCC Foundation awards for 2020-21 award year.
- Mid-March** Contact the Office of Financial Aid to request calculation of Summer 2020 aid.
- March 18** Spring 2020 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- April 10** Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the May 8, 2020 summer preregistration payment date.*
- April 10** Last day to apply for a Spring 2020 loan.
- April 22** Spring 2020 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- May 8** Summer preregistration payment due date.
- May 13** Spring 2020 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- June 4** Last day to apply for a loan for 6-week Summer 2020 classes.
- June 5** Summer 2020 Financial Aid Eligibility date - be enrolled for all summer courses, including 8-week and late starting, by this date.
- June 11** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 6- and 8-week summer classes
- June 18** Last day to apply for a loan for 8-week Summer 2020 classes.
- June 24** First date that 6-week Summer 2020 loans will be disbursed to qualified students.
- June 30** Last day to file a 2019-20 FAFSA; it must have a valid expected family contribution (EFC) amount from the federal processor.
- July 8** Summer 2020 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards
- July 22** Summer 2020 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- Aug. 12** Summer 2020 PELL grants and SEOG disbursed to qualified students with completed files and activated awards.
- Sept. 16** Final disbursement date for Fall 2019, Spring 2020, and Summer 2020 from all award sources.
