- Oct. 1** First day to file 2018-19 Free Application for Federal Student Aid (FAFSA). [www.fafsa.gov](http://www.fafsa.gov)
- Nov. 1** KCC Foundation Scholarship applications for the 2018-19 award year available online at [www.kcc.edu/scholarships/](http://www.kcc.edu/scholarships/).

- March 1** Scholarship application deadline for KCC Foundation awards for 2018-19 award year.
- June 21** Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the Aug. 3, 2018 fall preregistration payment date.\*
- Aug. 3** Fall preregistration payment due date.
- Sept. 7** Fall 2018 Financial Aid Eligibility date – be enrolled for all fall courses, including 8-week and late starting, by this date.
- Sept. 21** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting fall classes.
- Oct. 1** First day to file 2019-20 Free Application for Federal Student Aid (FAFSA). [www.fafsa.gov](http://www.fafsa.gov)
- Oct. 24** Fall 2018 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

- Nov. 2** Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the Nov. 30, 2018 spring preregistration payment date.\*
- Nov. 9** Last day to apply for a Fall 2018 loan.
- Nov. 21** Fall 2018 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- Nov. 30** Spring preregistration payment due date.
- Dec. 12** Fall 2018 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

### **2019**

- Jan. 25** Spring 2019 Financial Aid Eligibility date - be enrolled for all spring courses, including 8-week and late starting, by this date.
- Feb. 8** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting spring classes.
- March 1** Scholarship application deadline for KCC Foundation awards for 2019-20 award year.
- Mid-March** Contact the Office of Financial Aid to request calculation of Summer 2019 aid.
- March 13** Spring 2019 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- April 5** Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the May 3, 2019 summer preregistration payment date.\*
- April 5** Last day to apply for a Spring 2019 loan.
- April 17** Spring 2019 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- May 3** Summer preregistration payment due date.
- May 8** Spring 2019 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- May 31** Last day to apply for a loan for 6-week Summer 2019 classes.
- June 7** Summer 2019 Financial Aid Eligibility date - be enrolled for all summer courses, including 8-week and late starting, by this date.
- June 13** Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 6- and 8-week summer classes
- June 19** First date that 6-week Summer 2019 loans will be disbursed to qualified students.
- June 20** Last day to apply for a loan for 8-week Summer 2019 classes.
- June 30** Last day to file a 2018-19 FAFSA; it must have a valid expected family contribution (EFC) amount from the federal processor.
- July 10** Summer 2019 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards
- July 24** Summer 2019 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.
- Aug. 14** Summer 2019 PELL grants and SEOG disbursed to qualified students with completed files and activated awards.
- Sept. 18** Final disbursement date for Fall 2018, Spring 2019, and Summer 2019 from all award sources.
